## **Application Requirements**

In order to be considered for a low interest loan a complete application must be submitted to the Schulenburg EDC offices at

535 North Main Street

Schulenburg, TX 78956.

A complete application MUST include:

- Application
- Proof of ownership of property property tax statement
- Must be current with all taxing entities
- There must be no liens against the property or applicant other than a mortgage
- Proof of Commercial Lease & Approval from Property Owner (if application is not property owner)
- Site plans for the project
- Basic breakdown for use of funds
- Business office located in Schulenburg Taxing jurisdiction
- Project Timetable
- Inspection reports from the City of Schulenburg and Schulenburg Fire Marshall, Prior to Certificate of Occupancy being issued before opening.
- Approval from the historical Commission for the Project, if applicable.
- The SEDC will require a personal guarantee and executed contractual agreement.
- Must follow City of Schulenburg Permit process

Applications should be submitted by the 10th of each month in order to be listed on the next Board agenda for consideration. Applicants whose application is successful may not apply for additional funding within a twelve (12) month time period. Work may not commence on project until funding has been approved.
