



**City of Schulenburg  
Ordinance No. 091525  
Adopt 2025-2026 Budget**

**An Ordinance of the City of Schulenburg,  
Schulenburg, Texas Adopting the Budget  
For the Fiscal Year October 1, 2025 thru  
September 30, 2026 and Providing an Effective Date.**

**WHEREAS,** Notice of a public hearing on the Budget for the Fiscal **Year 2025 – 2026 has heretofore been published in accordance with the law; And,**

**WHEREAS,** A public hearing was duly held at the time and place as provided for in the notice of such public hearing and all interested persons were given opportunities to be heard on said Budget; And,

**WHEREAS,** **It is necessary, at this time, that said Budget be adopted.**

**NOW THEREFORE** be it ordained by the City Council of the City Schulenburg, Texas as follows:

**Section 1** That the Budget presented by the City Administrator and reviewed during the public hearing and is hereby approved and adopted for the Fiscal Year 2025 – 2026.

**Section 2** The City Administrator is authorized to invest any Funds needed for current use, whether Operating Funds or Bond Funds, in United States Treasury Bills, Savings Accounts, Money Market Accounts, and Certificates of Deposit in the City Depository and/or Tex-Pool. Interest accrued from such investments may be deposited in the General Fund and the Utility Fund. All of which investments shall be in accordance with the law.

**Section 3** That the City Administrator be and is hereby authorized to make Intra and Inter Department Fund Transfers during the Fiscal Year as becomes necessary in order to avoid over expenditure in a particular account.

**Section 4** By reason of the fact that the City Council considers the passage of this Ordinance necessary for the preservation of the public business of the City of Schulenburg, Texas; because such passage is mandated by State and/or Federal Law to be completed by September 30, 2025, and it is so ordained.


**Section 5** This Ordinance is effective upon approval.
